Exhibitor must abide by the published schedule of show hours, move-in and move-out times. Exhibitor must have booth occupied at least 30 minutes prior to the opening of the show Exhibitor may not terminate his/her exhibit and leave the show before the published closing of the show. It is Exhibitor's sole responsibility to leave the rented space in its original condition; otherwise Management may impose a trash removal or damage fee of at least \$50. Management assumes no responsibility and liability for merchandise or display left in exhibit area beyond the move-out time Exhibitor must have liability insurance for \$1,000,000.00 and name MANAGEMENT as additionally insured, and be responsible for his/her own liability and action resulting from the operation of his/her exhibit.
